This indenture made the twentieth day of January in the year of our Lord One thousand eight hundred and sixty one between Susannah Warland late of Harben Vale now of Maitland in the colony of New South Wales widow of the one part and Frederick Robert White of Timor near Murrarundi in the said Colony Esquire of the other part

Whereas William Henry Warland late of Harben Vale Page's River in the Colony aforesaid Esquire being seized among other hereditaments of the hereditaments hereinafter described by a codicil of his last Will and Testament bearing date the sixteenth day of July One thousand eight hundred and fifty one devised unto the said Susannah Warland and the Right Reverend William Tyrrell Lord Bishop of Newcastle and to Joseph Chambers of Maitland in the said Colony Gentleman all his Real Estate whatsoever upon trust (inter alia) to sell and dispose of his said Real Estate at such times an in such form and manner as they should deem fit


And whereas the said Testator departed this life on or about the eleventh day or December One thousand eight hundred and fifty nine without having altered or revoked his said will or codicil which was duly proved in the Supreme Court of New South Wales aforesaid in its ecclesiastical jurisdiction by Susannah Warland his widow

And whereas by deed of Renunciation date(d) the first day of October One thousand and eight hundred and sixty between the said Right Reverend William Tyrrell Lord Bishop of Newcastle and the said Joseph Chambers of the one part and the said Susannah Warland of the other part the said Lord Bishop and the said Joseph Chambers did renounce unto the said Susannah Warland her heirs executors administrators and assigns all the trusts estates and interests of them the said Lord Biship and the said Joseph Chambers as Trustees and executors of the said Will and Codicil

And whereas the said Susannah Warland has contracted and agreed with the said Frederick Robert White for the sale to him of the hereditaments hereinafter described at the price or sum of Seven thousand four hundred and thirty three pounds nine shillings stg free from encumbrances

Now this Indenture witnesseth that in pursuance of the said contract agreement and sale and in consideration of the sum of seven thousand four hundred and thirty three pounds nine shillings stirling of lawful money paid by the said Frederick Robert White to the said Susannah Warland on or before the execution hereof (the receipt whereof is acknowledged) she the said Susannah Warland in exercise of and pursuant to the power and direction in this behalf contained in the said Codicil to the said Will doth hereby grant bargain sell release and confirm unto the said Frederick Robert White and his heirs

And also (unless inevitable accident prevents) that the writing specified in the schedule firstly hereunder written shall from time to time or at any time or times to be produced to the said Frederick Robert White, his heirs or assigns, or to his or their nominee or nominees at any judicial investigation or otherwise as occasion shall require at the requests and costs (furnished) of the said Frederick Robert White his heirs (and) or assigns

And will at any time or times at the like request and costs furnish attested or other copies of or extracts from said writing

And the said Frederick Robert White for himself his heirs executors and administrators that he will from time to time at the request costs and changes of the party applying to him produce and show for them when and where required the said grants from which portions have been sold by the deed of grant to William Henry Warland of eight hundred and fifty six acres date the twenty ninth day of March one thousand eight hundred and thirty six and the deed of grants to the said William Henry Warland of nine hundred and sixty acres dated the eighteenth day of October one thousand eight hundred and thirty nine
